Dear KEG Members,

The Executive Council met on Wednesday, April 30, 2025 to further deliberate on the way forward as the Annual General Meeting slated for Saturday April 12, 2025, did not take place. The EC would like to make the following communication to members, even as we await the response from the Registrar of Societies.

1. That Section 29 of the Societies Act stipulates that every Society must hold an Annual General Meeting once a year to be in compliance with the law.
2. Article X (4) (on meetings) of the KEG Constitution stipulates that the General Meeting shall be held once a year.
3. Members have raised concerns, many of them touching on the KEG Constitution and the legal framework we are operating in. These issues need deeper exposition. In view of these fundamental issues, the Executive Council has resolved to hold a Webinar where a legal counsel will speak to the current state we are in; KEG constitutional issues and any other matters members feel are important to be discussed in this meeting. In this regard, the Executive Council hereby invites all members to a webinar on Monday, May 5 at 8pm.
4. The EC takes this opportunity to thank members who have sent in their submissions on proposed amendments to the constitution. These will be forwarded to the Constitutional Review Committee for collation. We would like to bring to the attention of members that the submission period has been extended by one week, until May 7, 2025 to allow more
